NOTES:

Please include Bill # and Phone # on checks.

You may total all bills, real estate and per capita, onto one check for each tax year.

When checks are not honored at the bank, the tax will remain unpaid.

The monetary check amount in "word form" must be correct for the bank to accept.

If you have an escrow account with your mortgage company, please do not also pay your real estate tax to avoid double payments. Mortgage companies do not pay per capita taxes, this is the individual's responsibility.

If you move out of the township, please contact the municipal office for a moving permit. This is needed to remove you from the per capita tax roll.

For a stamped paid receipt, you must return BOTH taxpayer and remittance copy of the tax bill with a self addressed stamped envelope OR a valid email address. State requires a paid receipt for the PA Property Tax Rebate.
