

LEHIGH TOWNSHIP BOARD OF SUPERVISORS

Minutes of the April 20, 2021, Meeting

- I. CALL TO ORDER. The Lehigh Township Board of Supervisors held a special meeting on Tuesday, April 20, 2021, at 7:00 p.m. The purpose of the meeting was to conduct necessary general business of the Board from the April 13, 2021, meeting which was canceled. The meeting was held at the Lehigh Township Municipal Building, 1069 Municipal Road, Walnutport, Pa. 18088. Chairman Cindy Miller called the meeting to order with the pledge of allegiance and roll call:

II. APPROVAL OF THE MINUTES

- A. Minutes of March 23, 2021. Keith Hantz made a motion to approve these minutes. Mike Jones seconded the motion. All voted aye. Motion carried.

III. APPROVAL OF BILLS

- A. General Fund Checks 24735 to 24779. Keith Hantz made a motion to approve these bills. Mike Jones seconded the motion. All voted aye. Motion carried.

IV. PLANNING RELATED ITEMS

A. Extension of Time to Record Plan

1. Lehigh Elementary School. The deadline to record this plan is April 30, 2021. The developer is requesting an extension of time until August 31, 2021, to record the plan. Terry DeGroot from Terraform Engineering was present to represent this plan. Mr. DeGroot commented they have been working through the PennDOT process. They have received the HOP and are now working on the details of the right of way transfer to PennDOT. They are doing the final title searches for PennDOT. As soon as the right of way transfer has been completed, they will be recording the plan. The new school is currently being constructed and they are going to be opening the school this fall. Once the new school is open, they will start removing items from the old building and the removal of it.

Keith Hantz made a motion to grant an extension of time until August 31, 2021, for the recording of this plan. Phil Gogel seconded the motion. All voted aye. Motion carried.

2. Tim Pitts Subdivision. The deadline to record this plan is April 30, 2021. The developer is requesting an extension of time until August 30, 2021, to record the plan. Mark Leuthe was present to represent this plan. Mr. Leuthe commented this plan has been running concurrently with the Northwoods Development because they will be sharing a sanitary sewer connection. They have submitted their private water permit to DEP. Once they receive approval from DEP for this permit, they will be submitting final plans to the Township.

Keith Hantz made a motion to grant the extension of time to record this plan until August 30, 2021. Mike Jones seconded the motion. All voted aye. Motion carried.

B. Extension of Time for Plan Approval

1. David Buechele Minor Subdivision. The developer granted the Board an extension of time until July 22, 2021. Mark Leuthe was present to represent this plan. Mr. Leuthe commented it took them some time until they were able to develop a maintenance agreement for a wall that is spanning the property line for future maintenance by the two property owners. He is expecting it to be submitted for approval at next month's Planning Commission meeting.

Phil Gogel made a motion to accept the extension of time until July 22, 2021. Mike Jones seconded the motion. All voted aye. Motion carried.

C. Plan for Approval

1. Thomas Phillips Lot Line Adjustment Plan. Mark Leuthe was present to represent this plan. It is a simple lot line adjustment between Mr. Phillips and Archery Addictions to increase Mr. Phillips lot and make the lot more conforming. A review letter by Hanover Engineering dated April 8, 2021, outlined the outstanding conditions of the conditional approval letter by the Planning Commission.

Phil Gogel made a motion to grant this plan conditional approval subject to the outstanding items in the Township Engineer's letter dated April 8, 2021, and the Planning Commission conditional approval letter dated March 17, 2021. Mike Jones seconded the motion. All voted aye. Motion carried.

V. OLD BUSINESS. There was no old business.

VI. NEW BUSINESS

A. Sale of Equipment. All of the items have been listed on Municibid which is an on-line public auction. Copies of the auction report have been provided to the Board.

1. 1996 Wells Trailer. Phil Gogel made a motion to award the bid for the sale of the 1996 Wells Trailer to Kevin McWilliams at a price of \$2,400. Keith Hantz seconded the motion. All voted aye. Motion carried.
  
2. 2013 Dodge Charger. When high bidder for this vehicle was notified that he won the bid on Municibid, he contacted Municibid and the Township and indicated that his sons bid on the vehicle without his permission and he did not want the vehicle. As a result of this, they ran the bids up from the time they started bidding on it at \$3,100 and it went until \$6,000. Alice Rehrig contacted the next highest bidder who indicated he would be willing to purchase the vehicle at a price of \$3,600 which was his last bid before the car was bid up by the other individual. There were competitive bids until \$2,500, but from that time on, it was only between the top two bidders. The Board would have the option of selling the car for \$3,600 or putting it back out to bid. There will most likely be penalties from Municibid for the other individual bidding on the vehicle and not taking it.

Keith Hantz made a motion to award the bid for the sale of the 2013 Dodge Charger to Roy Thompson at a price of \$3,600. Phil Gogel seconded the motion. Mike Jones questioned why it wouldn't be at a price of \$4,000 because that is what his proxy bid was. Alice Rehrig noted that it only reached the proxy amount because the other bidder was bidding against Mr. Thompson. All voted aye. Motion carried.

3. 1999 Freightliner Dump Truck. Phil Gogel made a motion to award the bid for the sale of the 1999 Freightliner Dump Truck Michael Swope at a price of \$25,500. Keith Hantz seconded the motion. All voted aye. Motion carried.
  4. Exmark Mower #1. Phil Gogel made a motion to award the bid for the sale of the Exmark Mower #1 to Jeffrey Brewer at a price of \$2,050. Keith Hantz seconded the motion. All voted aye. Motion carried.
  5. Exmark Mower #2. Keith Hantz made a motion to award the bid for the sale of the Exmark Mower #2 to Justin Francomacaro at a price of \$2,701. Mike Jones seconded the motion. All voted aye. Motion carried.
  6. Salt Dog Salt Spreader. Phil Gogel made a motion to award the bid for the Salt Dog Salt Spreader to Tyler Hantz a price of \$91. Mike Jones seconded the motion. Phil Gogel, Cindy Miller, Mike Jones, and Mike McGonigle voted aye. Keith Hantz abstained because the purchaser is his relative. Motion carried.
  7. Bolens Hydro Tractor. Phil Gogel made a motion to award the bid for the Bolens Hydro Tractor to Jamie Homan at a price of \$41. Mike Jones seconded the motion. All voted aye. Motion carried.
- B. Manager's Report. A resident requested that the issue of feral cats be brought to the Board to see if they would consider including something in the 2022 Budget to help control the population. The Board was not in favor of developing a program at this time. Residents need to stop feeding the stray cats.

Alice Rehrig questioned if summer help was going to be brought in this year. Keith Hantz commented it was included in the budget and there are no plans on replacing the retired employee until the fall. He thinks we should move forward with advertising. Alice Rehrig commented there are 1664 hours included in the budget. We can hire up to three individuals. Phil Gogel commented he liked the way the time was utilized in the past where the summer help didn't come in if the weather was bad. The Board agreed it should be advertised to bring in summer help.

Alice Rehrig reported the insurance proposals will be due this week, the ordinance for the Bed & Breakfast criteria will be on the May 11 agenda. All the other items from the April 13 meeting will be on the April 27 agenda.

VII. PUBLIC COMMENT. Mike Jones commented he wanted to discuss the parks since he will not be at the next meeting. He believes what happened on Tuesday, Wednesday, and Thursday and the total overreaction needs to be discussed. His first biggest gripe is who gave them the authority to do what they did. Cindy Miller commented the Rec Board did. Mike Jones commented they didn't; he has read their minutes. Mike Jones commented the infield was altered and now we can't take care of the infield. Cindy Miller commented they have agreed to take care of the infield. Who gave them the permission to do so? Cindy Miller commented she watched the whole thing because she knew there was going to be a big explosion. Vinnie Eiden and Frank Zamadics talked it out. Frank Zamadics agreed that Vinnie Eiden and the others would take care of the infield and our staff would take care of the outfield. Mike Jones commented our staff can't take care of it because of the width of the base paths. The field was altered to make the base paths smaller and now we can't drag the field because our equipment will not fit within the path. Cindy Miller commented the field was made to regulation. Mike Jones commented the field was still altered. Keith Hantz commented they did this seven or eight years ago. Mike Jones commented it is not regulation. It was regulation before they changed it. They wanted to make it their way so that is what they did. Cindy Miller commented from what she understands, it was made to high school regulation. Mike Jones commented regulation base paths are six feet. Are we now saying that if someone wants to go to a park and alter something, they can without getting any kind of authorization to do so? That's what they did. Cindy Miller commented from what she understood, the Rec Board approved it. Sandy Hopkins was at the field. They've been working on it for two weeks. Phil Gogel commented he remembered some permission being given for stone. Mike Jones commented they knew about the pitcher's mound and drain, but not altering the base paths. Saying someone should be fired over this is idiotic. Mike Jones commented he went through the Board minutes back through June and this was not in it one time. Phil Gogel commented he remembered something about David Hess donating the clean 2B stone. Mike Jones commented that was in the Rec Board minutes and never brought up to the Board and in our minutes. It was not brought up during the Recreation Report. Keith Hantz commented it is in the Rec Board minutes. That was for the drain by the dugouts.

Keith Hantz commented he believes what is upsetting Mike Jones is that the Recreation Board is an advisory Board to the Supervisors. If they approve something at their meeting, it should be brought to the Supervisors for approval, just like the dog park. We went through this eight or nine years ago. Too many people think the Berlinsville Ballfield is their personal ballfield and they go out and do what they want. He thinks the Rec Board probably didn't know about this when he sees the names of the people involved. Cindy Miller commented she thinks Sandy Hopkins probably did know

because she has been out at the field over the past two weeks, but she can't speak for her. She doesn't think it is right that we are talking about this when the people who were involved are not here.

Phil Gogel questioned if the field was ruined. Mike Jones commented no, in a half an hour with a rake, it was fixed. The whole thing was blown out of proportion. He doesn't know how you would get from the outfield to the infield without driving on the dirt. Phil Gogel commented he is referring to the people who went and worked on the field. Keith Hantz commented whatever work was done, the Public Works Department is being told they didn't maintain it right. Cindy Miller commented they went in and cut the sod and drove over the clay. Phil Gogel commented he doesn't believe they did it on purpose. Mike Jones questioned how they would get to the infield without crossing over the dirt. Phil Gogel questioned if they didn't know the sod was there. Frank Zamadics commented they didn't get a call that there was any work being done out there. Cindy Miller questioned how many times Frank Zamadics was out at the field over the past couple of weeks and saw them working there. Frank Zamadics commented he personally was not at the field. He had the water turned on and they guys were there. He doesn't know if they were there when they were working on the field. He was told there was going to be pitcher's mound clay delivered and put in the dugout and that there was an area of sod that was going to be repaired in front of the pitchers mound. He was not aware of any alterations to the field going from home to first base or home to third base. Phil Gogel questioned if it looks nice. Cindy Miller commented it does. Mike Jones commented he thinks it looks weird because the base path goes, then it stops. It should go all the way to the outfield. Cindy Miller commented she doesn't think they were totally done, but she doesn't know. Mike Jones commented it also bothers him that it says in the Rec minutes that Vinnie Eiden should email Alice Rehrig what he is doing on the field, but there was not an email. They are doing whatever they want on the field and everything is swept away. Cindy Miller questioned if Alice Rehrig received that email. Alice Rehrig commented she did not. Cindy Miller commented it seems that she knew the email would be coming, but it was never questioned, yet people were working on the field for two weeks. She saw people working on the field for two weeks when she drove by, but didn't stop and question what they were doing. She figured Rec Board was dealing with it. Mike Jones questioned if the individuals are taking care of the infield, will they be taking care of it for everyone? Cindy Miller commented from what she understood, they were taking care of the infield and the Public Works was supposed to take care of the outfield from the 1<sup>st</sup> and 3<sup>rd</sup> base out. Frank Zamadics commented that is what he wants to know, is that the Board is okay with the Crew maintaining the outfield and the others taking care of the infield. Cindy Miller commented that was what they told Frank Zamadics when they were at the field. Mike Jones commented they shouldn't be telling us what to be doing. It is our park. It doesn't matter whether or not they are volunteering. Just because they are volunteering, doesn't mean they should be able to go

and do whatever they want to do. Keith Hantz commented the Rec Board is an advisory Board and they should be coming to the Supervisors when changes are going to be made. Cindy Miller questioned if Keith Hantz would have said yes if they would have come in. Keith Hantz commented he would have said no. Cindy Miller commented a person put out over \$1,000 to do the field and make it look nice so that these teams that are coming in and using the field have a nice field to use. They said they are willing to maintain the infield and our Public Works Crew only has to maintain the outfield and you would say no, but you were okay with the dog park? She doesn't understand why. Is it because it is not LTAA? It's because of the fighting that goes on among these teams for the past eight years. She's sick if this. Mike Jones commented what happens if next year, this team folds up and we can't do the base paths? Are we going to buy new equipment or tear out the grass? The question that was raised with the dog park was "what is it going to cost us to maintain it?" The answer was nothing other than weed whacking and cutting the grass. With this project, if they stop taking care of the field, it will cost us money to maintain it. Cindy Miller questioned how it would cost us money to maintain it if we have maintained it in the past. Mike Jones commented it is because the base paths were narrowed. Frank Zamadics commented their machine that runs the infield and does the conditioning is six feet wide and will not fit in the paths. They have the base paths down to about 30 inches. David Hess commented he didn't assume they were going to change things to make it narrow. He assumed at the meeting they were going to fix the mound and do some repairs which is why he made the comment that he should notify Alice Rehrig about what they were going to do. He doesn't believe they were very clear in the meeting as to what they were going to be doing. At the meeting, both Vinnie Eiden and Jeff Erschen were talking almost at the same time which is why he wanted them to let Alice Rehrig know what was going on.

Cindy Miller commented she is not comfortable having this conversation without all the parties that were involved being at the meeting to speak about this. She doesn't want to put words into Sandy Hopkin's mouth. Mike Jones commented David Hess is on the Rec Board and he didn't know what was going on. He knew about the mound which was in the minutes and fixing up some of the infield which is in the minutes. David Hess commented he didn't think they were going to change anything. Mike Jones commented this is what always happens, again and again. Cindy Miller commented they do not think it is their field. She is tired of hearing it. Keith Hantz commented they do. Mike Jones commented read the minutes. It's every meeting. When Cindy Miller attended the meeting back in October, she even stated it is not a profession park. It's not Coca-Cola Park. Cindy Miller commented in her opinion, she doesn't see anything wrong with what they did. Phil Gogel commented it seems like they did a nice job, but just went a little overboard. Cindy Miller commented people are angry because there is a personality problem with these people. That's what's going on here. Mike Jones commented that is

not the case. Keith Hantz commented Cindy Miller had a problem also until about three months ago because she needs them. Cindy Miller commented the comment doesn't make sense, and words shouldn't be put in her mouth.

Keith Hantz commented he thinks they should rip the sod out because they didn't get permission to put it in and that our Public Works Department can continue to maintain the fields. We shouldn't have a volunteer maintaining the field because what happens if when they are cutting the grass a rock flies out and hits someone or they get hurt while they are out there. Who will be responsible? Phil Gogel commented he thinks the Township would be liable any time someone would get hurt when they are on our parks. Keith Hantz commented they are not using the parks; they are performing maintenance. Phil Gogel questioned if they carry insurance. Keith Hantz commented if they are a registered team, but Vinnie Eiden is not a registered team. Alice Rehrig commented Vinnie Eiden's team is not considered to be a home team, but all the teams that use the field provide a certificate of insurance. Mike Jones commented we are letting a non-home team alter the field to their liking. Keith Hantz commented he would want to see where their liability insurance would cover them for cutting the grass. Also, why must we keep adding to Berlinsville. Cindy Miller commented it was her understanding that they were going to do work in Danielsville also. Mike Jones commented that is Jerry Pritchard and ECTB. They were not going to be altering the field. They were just going to fix the gate and put caps on the fencing. It was being done to rent the field to ECTB to bring in some revenue. The Berlinsville field was being fixed up to their liking and that is it. They flip out whenever another team uses the field. Cindy Miller commented in order to continue this conversation, we need to have them in the room. No one else would want to have a conversation about them without them being here. This is not on the agenda and no one is here to talk about it. We should be hearing about what is going on from the individuals who were involved. Mike Jones commented they are not even on the Rec Board. If the Rec Board didn't say yes, then they shouldn't have done it. Keith Hantz commented that is why he thinks the sod should come out now, before it grows in any deeper. Tomorrow, they should go and take the sod out and put it back to the way it was. Where was it approved by anyone? He doesn't believe Sandy Hopkins approved it. It is nowhere in the minutes. It is listed in the minutes about doing the drain and the pitcher's mound.

Phil Gogel questioned what they use to maintain the infield. Cindy Miller commented she didn't know. She just knows they said they would be willing to take care of the infield and Public Works would take care of the outfield. Phil Gogel questioned what the main point of contention was with this. Mike Jones commented all three of our fields are maintained, but Berlinsville is not to their liking and their specs and they have a fit whenever another team plays there. Phil Gogel commented it seems like the stone and

the pitcher's mound were okay. Keith Hantz commented those items were approved in the minutes and are maintenance items. Cindy Miller commented how can some work be okay and not the rest. The Rec Board didn't come to the Board about the pitcher's mound or the stone. Mike Jones commented those are maintenance items. They didn't alter the field. Phil Gogel commented it seems like the narrowing of the base paths is the issue. Cindy Miller questioned why the Township cannot maintain the field if we had to. Frank Zamadics commented the machine is 72 inches wide; angled, he could probably get it down to about 66 inches. If they take that machine down the base paths now, it will chew everything up.

Keith Hantz commented what he doesn't like is that it was done without anyone's permission, not even the Rec Board. If the Rec Board wants to change something on the fields, they should come to the Supervisors and let them know. Cindy Miller commented she would like to hear from Sandy Hopkins and the people who were involved. We're making assumptions. Keith Hantz commented he believes the sod should come out.

Phil Gogel questioned if the team has a smaller machine than we do to maintain it. Frank Zamadics commented they do it by hand with steel rakes. Mike Jones commented the drag for the field is also six feet so the drag cannot go down the base paths. Keith Hantz commented the machine and the drags fit in the base paths until they were altered. Phil Gogel questioned if the mound and dugouts are okay. Frank Zamadics commented the mound is good and the dugouts are fine. They opened a drain that was installed about 15 years ago. Keith Hantz commented these are maintenance items on the field; things that were already there. Phil Gogel commented it seems like they did a little extra and didn't realize they were doing wrong. Keith Hantz commented it was not just a little extra; it was expensive. Phil Gogel commented he is not minimizing the amount of work that was put into it. Mike Jones commented they must be planning on doing additional work because there is a half pallet of sod still sitting out there. Cindy Miller commented her understanding was they were going to do some work at Danielsville, but she doesn't know because she was not at any of the meetings. She was only at the field that one time listening to Vinnie Eiden and Frank Zamadics talking, and Sandy Hopkins was there.

Keith Hantz questioned if Frank Zamadics knows what they want to do at Danielsville. Frank Zamadics commented he was not aware of anything. Mike Jones commented according to the minutes they would like to do work on the gate because it doesn't close for tournaments. He's assuming that is the large gate in center field. Phil Gogel questioned if they are looking to narrow anything at Danielsville. Cindy Miller commented we don't know. That is why she doesn't want to have this conversation tonight when the people who are involved are not in the room to discuss it. Keith Hantz commented if you look at the minutes, it states that Jerry Pritchard commented that

ECTB is interested in renting the fields in Danielsville and will be calling the Township to schedule. The fields will need attention if they are going to be used this year. Cindy Miller commented we don't know what "attention" means which is why the people involved should be here. Phil Gogel commented he would like to hear what their thought process was as far as the maintenance. Keith Hantz commented they don't want the Township touching the infield. Mike Jones commented the infield would need to be hand raked. Based on the minutes, it looks like there will be a lot of teams out there this year. Are they going out after each team uses the field? Cindy Miller commented it was just stated that they would maintain the infield and the Township would maintain the outfield. Keith Hantz commented Vinnie Eiden isn't even a Township resident. Cindy Miller commented it doesn't matter. He is renting the field and she stood there and listened to what he had to say. Keith Hantz commented to him it makes a difference. Cindy Miller commented you guys are going off in tangents. She is cutting this discussion off because the people involved are not here. Keith Hantz commented Cindy Miller did not have right to cut off the conversation because she is hearing what she doesn't want to hear. He has a feeling she may have made an agreement on something. Cindy Miller commented she didn't agree to any of it. Don't be accusing her. Keith Hantz commented he was told she did. Cindy Miller questioned who told him that? Keith Hantz questioned who she talked to? Cindy Miller commented she stood at the field. Frank Zamadics, Vinnie Eiden, and Sandy Hopkins were there. That was it. Keith Hantz questioned if there was a phone conversation with Vinnie Eiden. Cindy Miller commented he called her, but she did not agree to anything. Keith Hantz commented, yeah, right. Cindy Miller then told Keith Hantz to go to hell, she is moving on to the next part of the agenda. The people who can answer the questions are not here. This needs to be left alone for now and move on the agenda. Keith Hantz commented there was no permission given. For ten years, the base paths worked for everyone. Mike Jones commented Vinnie Eiden called him and said he was given permission to take care of the infield when he was at the field with Cindy Miller. Cindy Miller commented he said to Frank Zamadics that he would take care of the infield and Frank Zamadics told him fine, they would just take care of the outfield. Frank Zamadics agreed to it; she stood there and watched it. She didn't tell him what to do. Frank Zamadics commented he said he would need Board permission. He wasn't going to make that assumption on his own. It is a Board decision. They haven't done anything out at the field since that meeting other than water the sod; he's been out there and done some watering also. He just believes there needs to be a discussion amongst the Rec Board and Supervisors. He just needs to hear the outcome and be told whether or not he is to maintain the infield. Keith Hantz commented he thinks the public works should be taking care of all of our parks.

Frank Zamadics commented he also would appreciate if the bashing of the Road Crew would be put to the side. It is a Township park being maintained by the Township Crew. The maintenance on that park is no different than the maintenance on any other park.

The Berlinsville Park is the one with all the problems. The Crew gets bad mouthed for doing the maintenance items that they should be doing. He would like it to drop.

Keith Hantz commented if as a Board they are not making a motion to tell Vinnie Eiden to maintain the infield, then the Public Works should continue to be doing it. It is their responsibility. Frank Zamadics commented the coaches have always done their own dragging of the field and lining of the field. The Road Crew goes in two or three times a year with the power rake to work the conditioner into the field, spray the weeds, and spray the outfield. As far as fertilizing and weed control on the outfield, that needs to be done by himself because he holds the license for spraying. Cindy Miller commented the field has been cut. This can wait for another week until the next meeting when the Rec Board can be present. Frank Zamadics commented he doesn't need to do anything with the infield. He doesn't have to do anything with the conditioner. It is all out there. They said they would take care of it. If everyone can live with things the way they are for a week, it can wait until the next meeting when it is further discussed. Keith Hantz commented he will not be at the next meeting, nor will Mike Jones. Frank Zamadics commented if it waits to the next meeting, that's fine. He would just like to be here for the discussion. Cindy Miller commented she agrees that would be a good idea. The Supervisors also need to hear from the Rec Board so they know what's going on. Phil Gogel commented there has to be a balance where if Frank Zamadics thinks it's a good idea because he can have people doing something else instead of the field or if it is a bad idea because it would cause a problem. Keith Hantz questioned what Frank Zamadics is supposed to do when he is being pulled in different directions from the Rec Board. Phil Gogel commented the Rec Board should get together with an idea and then Sandy Hopkins should be the only person who goes to Frank Zamadics and if they come up with a solution, then when the Board has their first meeting of the month, they can present the case, and if everyone is in agreement, then there shouldn't be an issue. Keith Hantz commented the only thing that should really need to be brought to the Board is if they want to change something at a park. Just like when they wanted to put in the dog park, they brought it to the Board. Phil Gogel commented he can agree that things shouldn't be altered without coming to the Board. He doesn't know if they meant to alter things. He believes they thought they were doing something good. Frank Zamadics commented he received a call that there was vandalism done to the field. That is really out of the question. There was nothing of the sort. It was also said that the guys did it as a personal attack. Three of the guys didn't grow up in the Township; two of them still commute into the Township. He does not know where the idea came from that it was vandalism or that it was done for spite. It was Township employees maintaining a township park. The maintenance program is no different from one park to another. It is all the same. They go out weekly and do the mowing, the spraying and whatever else is needed or that comes up. The whole thing of it being vandalism or retaliation is just crazy. Cindy

Miller commented she heard that, and she said she is not accepting that. Frank Zamadics commented he heard that came up again at the Rec meeting and he wanted to put the idea that it was vandalism or intentional to rest.

Phil Gogel suggested to David Hess that at the next Rec Board meeting they discuss what all they want done at the parks and then Sandy Hopkins can talk to Frank Zamadics once the Rec Board figures it out. Cindy Miller commented it should then be presented to the Supervisors so they know what is going on. Mike Jones commented he doesn't mind if they are repairing things. They just shouldn't be altering things to make it how they want it. That is what bothers him. He understands they like baseball and they want to make it look nice, but they can't be altering the Township fields and property. Any resident of the Township should be able to go to the fields and be able to use them when they want to. Keith Hantz commented if someone wants to use the field, they can gladly remove the tarps to use it. Mike Jones commented he has heard that they have tried to chase people off the field. Keith Hantz commented they have tried, but it is a Township park. Phil Gogel commented no one should be chased off our parks. Cindy Miller questioned if it happened this year. Mike Jones commented not that he was aware of. Phil Gogel commented the parks are there for the enjoyment of residents. Mike Jones commented as long as there is nothing scheduled on the field, people should be able to use the field.

Mary Trexler questioned if the Board was ever able to get in touch with the lady who lives across from the field. Alice Rehrig commented she had received an email from the property owner outlining her concerns and indicated that she does not have an objection to one adult coming onto the property to retrieve baseballs. She does not want multiple kids or people roaming around on her property. Alice Rehrig commented she provided a copy of the email to the two teams that are using the field. She will also be providing the tournament organizer with a copy of the email as well. Cindy Miller questioned what is being done about her tenant who keeps threatening people. They need to call the police if that happens. Why have people retrieve balls and antagonize the situation? Phil Gogel commented having netting installed may be a project that could be done through the Jaindl project.

- VIII. EXECUTIVE SESSION. The Board went into Executive Session to discuss a collective bargaining agreement. No action was taken.
- IX. ADJOURN. Phil Gogel made a motion to adjourn. Mike Jones seconded the motion. All voted aye. Motion carried.
