**A RESOLUTION OF LEHIGH TOWNSHIP, NORTHAMPTON
COUNTY, PENNSYLVANIA, ESTABLISHING A LIST OF FEES
FOR DOCUMENT REPRODUCTION, REPORTS, ADDITIONAL
SERVICES, TO INCLUDE VEHICLE STORAGE AND RELEASE
FEES FOR IMPOUNDMENT OF VEHICLES, AND REQUESTS
FOR NON-CRIMINAL FINGERPRINTING BY THE LEHIGH
TOWNSHIP POLICE DEPARTMENT.**

WHEREAS, the public, from time to time, requests from the Lehigh Township Police Department copies the following documents: logs, incident reports, and crash reports; and

WHEREAS, the Township of Lehigh may store vehicles due to impound or seizure; and

WHEREAS, the Township of Lehigh may provide fingerprinting services upon request for employment or other non-criminal purposes; and

WHEREAS, the Township of Lehigh wishes to establish reasonable fees to cover the cost of providing copies of said documents & providing the specified services to the public:
